




Figure 1: Survey progress of the additional study Baden-Wuerttemberg (Measurement points 1-3)




Figure 2: Field times and realized case numbers of school year 2010/11 (Measurement point 1)




Figure 4: Field times and realized case numbers of school year 2012/13 (Measurement point 3)
